PRIVACY POLICY FOR DAN-DOORS A/S

It is important for DAN-doors to protect the personal data you share with us. Therefore, we have a personal data policy that ensures you that we process your information responsibly and with respect for your privacy and in accordance with the applicable legislation in the area.

By using our website, you accept that we process your personal data as described in this privacy policy.

1. Collection of personal data

Personal data covers all information that can be used to identify a person, including first and last name, e-mail address or other contact information.

Your personal data is collected in one or more of the following cases:

- When you enter into a customer relationship with us
- When you sign up for DAN-doors' newsletter
- When you participate in DAN-doors' events
- When you request material to be sent to you
- When you communicate with us
- When you use DAN-doors' other functions and services
- When you visit us on social media

DAN-doors may register the following types of personal data about you:

- Contact information, including name, work address, work telephone number and work email
- IP address
- Segmentation data based on, for example, geodemographics

2. Processing of personal data

The purpose of our processing of your personal data is primarily to fulfil requests received from you. In addition, we may have an interest in processing your personal data in connection with our marketing, in the development of existing and new services and products, in connection with analyses and statistics of our customer segments and products, or if you have given specific consent to a specific processing.

The above may be updated at any time in line with any changing business needs and legal requirements.

3. Storage of your personal data

All personal data is stored in a secure manner and is only accessible to relevant DAN-doors employees.

4. Disclosure to third parties

We never disclose your personal data to third parties without your consent, unless it is necessary for the fulfilment of an agreement to which you are a party.



5. Access to personal data

You have the right to know what personal data we have registered about you and, in certain cases, you have the right to receive the personal data we have registered about you in a commonly used and machine-readable format.

You may at any time exercise your right to have the data we collect about you deleted, subject to certain statutory exceptions. You are also entitled to object to the collection and request that the processing of your personal data be restricted. If your personal data is incorrect, you have the right to have it corrected.
